ELIGIBILITY

APEGS members interested in being considered for a three-year volunteer term on an APEGS Committee must:

- Reside in Saskatchewan
- · Be a member in good standing; and
- Be Continuing Professional Development (CPD) compliant

In good standing includes paying annual fees and not under APEGS disciplinary actions. Coun15.0 Volunteer Eligibility and Expectations policy outlines that former employees are ineligible to serve as a volunteer for two years after employment has ceased.

EXPECTATIONS

- Three-year volunteer term
- Attend regularly scheduled meetings; and,
- Be prepared to fully participate in discussions at committee meetings
