The APEGS Council held an in-person meeting on November 30, 2022 at the DoubleTree Hilton Hotel in Regina, Saskatchewan. Virtual participation was also made available for those unable to attend in-person. The meeting was attended by Council, Directors to Engineers Canada and Geoscientists Canada and senior staff. The next Council meeting will be on March 3, 2023 in Saskatoon.

## Council approved the following motions:

- Approved the consent agenda which included board and committee minutes, Registrar's report, financial statements and updates from the constituent societies.
- Approved the September 22, 2022 meeting Minutes as presented.
- Approved Life Member applications of eight members.
- Approved the new Regulatory Board and Committees work plan.
- Approved changes to the Registrar's Advisory Committee Terms of Reference.
- Approved the new Reg1.1 Validator Requirements policy; updated Reg1.0 Professional Member
   Application Reference Requirements policy and archived Reg1.0 Professional References policy.
- Approved changes to AR2.0 Looking to Waive policy.
- Approved the development of a strategy and policy for APEGS Council consideration respecting the Truth and Reconciliation Commission's Calls to Action presentation and proposal to happen within the next one to three years.
- Approved the 2023 budget as presented.
- Approved the 2022 annual report outline as amended to include the land acknowledgement.
- Approve the business continuity plan (BCP) in principle. Some amendments will be made once the human resource review is complete and an Information Technology (IT) manager is hired.
- Approved the Governance Board Terms of Reference and Work Plan.
